~~(E) (D) (1) A PERSON MAY NOT KNOWINGLY POSSESS COMBINATIONS A COMBINATION OF ELECTRONIC SERIAL NUMBERS AND MOBILE IDENTIFICATION NUMBERS THAT WILL FACILITATE TELECOMMUNICATION SERVICE WITHOUT THE CONSENT OF THE LAWFUL OWNER.~~

(2) A PERSON WHO VIOLATES THIS SUBSECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN \$2,500 OR IMPRISONMENT FOR NOT MORE THAN 3 YEARS OR BOTH.

~~(E) (E) (1) A PERSON MAY NOT KNOWINGLY POSSESS ELECTRONIC SERIAL NUMBERS AND MOBILE IDENTIFICATION NUMBERS IN SUFFICIENT QUANTITIES THAT WOULD BE INDICATIVE OF INDICATE AN INTENT TO DISTRIBUTE, MANUFACTURE, OR SELL AN ELECTRONIC SERIAL NUMBER AND MOBILE IDENTIFICATION NUMBER COMBINATION.~~

(2) A PERSON WHO VIOLATES THIS SUBSECTION IS GUILTY OF A FELONY AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN \$10,000 OR IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR BOTH.
