~~(5) A LENDING INSTITUTION THAT ACCEPTS A HISTORIC REHABILITATION MORTGAGE CREDIT CERTIFICATE FROM A BUSINESS ENTITY OR INDIVIDUAL SHALL IN EXCHANGE PROVIDE THE BUSINESS ENTITY OR INDIVIDUAL AN AMOUNT EQUAL TO THE FACE AMOUNT OF THE HISTORIC REHABILITATION MORTGAGE CREDIT CERTIFICATE, DISCOUNTED BY THE AMOUNT BY WHICH THE LENDING INSTITUTION'S FEDERAL INCOME TAX LIABILITY IS INCREASED AS A RESULT OF ITS USE OF THE HISTORIC REHABILITATION MORTGAGE CREDIT CERTIFICATE TO OFFSET STATE TAXES UNDER THIS SUBSECTION, TO BE APPLIED:~~
