- (h) The Administration may not waive a vision examination required under this section.
- (I) (1) THE ADMINISTRATION SHALL UNDERTAKE A REVIEW OF THE CONTENT OF THE DRIVER EXAMINATION GIVEN TO AN APPLICANT FOR A DRIVER'S LICENSE UNDER THIS SECTION AND SHALL EVALUATE THE EFFECTIVENESS OF THE EXAMINATION WITH RESPECT TO ITS ABILITY TO ADEQUATELY MEASURE THE APPLICANT'S SKILL IN DRIVING UNDER ACTUAL HIGHWAY CONDITIONS.
- (2) AS PART OF THE REVIEW REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE ADMINISTRATION SHALL DEVELOP A DRIVER ROAD EXAMINATION THAT:
 - (I) INCLUDES ACTUAL HIGHWAY DRIVING:
- (II) PROVIDES OPPORTUNITIES TO EVALUATE THE APPLICANT'S ABILITY TO RESPOND TO COMMON HIGHWAY CONDITIONS THAT DEMAND THE APPLICATION OF THE GOOD JUDGMENT AND SAFE DRIVING SKILLS THAT A COMPETENT DRIVER SHOULD POSSESS; AND
- (III) ENSURES STANDARDIZATION OF TESTING PROCEDURES AND OBJECTIVITY OF SCORING CRITERIA.
- (3) (I) THE ADMINISTRATION SHALL IMPLEMENT THE DRIVER ROAD EXAMINATION DEVELOPED UNDER THIS SUBSECTION AS PART OF A DRIVER PERFORMANCE EVALUATION PILOT PROGRAM TO BE ESTABLISHED BY THE ADMINISTRATION IN AT LEAST ONE COUNTY.
- (II) AS PART OF THE PILOT PROGRAM, THE ADMINISTRATION SHALL:
- 1. EVALUATE THE DRIVER ROAD EXAMINATION OFFERED UNDER THE PILOT PROGRAM WITH RESPECT TO ITS EFFECTIVENESS IN ENSURING THE COMPETENCY OF DRIVERS: AND
- 2. DETERMINE THE RELATIVE MERITS OF THE DRIVING ROAD EXAMINATION OFFERED UNDER THE PILOT PROGRAM IN COMPARISON WITH THE DRIVER SKILLS EXAMINATION OFFERED TO LICENSE APPLICANTS ELSEWHERE IN THE STATE.
- (4) UNDER THE DRIVER PERFORMANCE EVALUATION PILOT PROGRAM, THE ADMINISTRATION MAY:
- (I) CONDUCT DRIVER SKILLS EXAMINATIONS OR DRIVER ROAD EXAMINATIONS FOR INDIVIDUALS SEEKING A LICENSE; OR
- (II) AUTHORIZE PERSONS UNDER CONTRACT WITH THE ADMINISTRATION TO PROVIDE DRIVER SKILLS EXAMINATIONS OR DRIVER ROAD EXAMINATIONS.
