

Henry Matthews, aged about twenty one years, light complexion, five feet five inches and a half high, scar on the fore finger of the left hand, born free and raised in Baltimore County, certificate issued the 20<sup>th</sup> day of August 1846 on <sup>affirmation</sup> of George Elliott

Maria Dorsey, aged about forty years, dark complexion five feet three and a half inches high, no visible marks, manumitted by Henry C. Hobbs, by deed bearing date the 16<sup>th</sup> day of April 1811, and Recorded among the Manumission Records of Anne Arundel County, in Liber B. No. 2, folios 131 & 132 - certificate issued on testimony of James N. Hobbs, September 22<sup>nd</sup> 1846.

Andrew Edward Clark, aged about twenty one years, dark complexion, five feet ten inches high, a scar above the left eye, and one on the upper joint of the left thumb, born free and raised in Howard District - certificate issued the 12<sup>th</sup> day of February 1847 on oath of Anthony Smith.

Henry Johnson, aged about thirty three years, light complexion, six feet two inches high, no visible marks present; manumitted by deed by deed bearing date the 10<sup>th</sup> day of April in the year 1815. in Liber B. folio 31 one of the Records of Anne Arundel County, and in Liber J. L. M. No. 1 - one of the Chattel records of Howard District of Anne Arundel County - certificate issued the 16<sup>th</sup> March 1847 on oath of Lenox J. Martin -

Janny Scott, aged about thirty seven years, dark complexion, five feet one and a half inches high, a mark on the fore finger of the <sup>right</sup> hand, manumitted by deed by deed bearing date the 10 day of April in the year 1815. in Liber B. folio 31. one of the Record Books of Anne Arundel County, and in Liber J. L. M. No. 1 one of the Chattel Record Books of Howard District of A. A. Co. - certificate issued 16. March 1847 on oath of Lenox J. Martin.

Louisa Snowden aged about thirty years dark complexion five feet five inches high has lost all her upper front teeth. Born free and raised in Howard district of Anne Arundel County. Certificate issued on the 18<sup>th</sup> day of May 1847 on the oath of Jane Scott.

Samuel Brookes aged about twenty two years dark complexion five feet eight and a half inches high has a scar on his chin born free and raised in Howard District of Anne Arundel County. Certificate issued on the 2<sup>d</sup> day of August. 1847 on the oath of John Forrest.

George W. Johnson, aged about twenty three years very light complexion five feet seven and a half inches high has the mark of an axe on the two large toes of his right foot, was born free and raised in Howard District of Anne Arundel County. Certificate issued the 2<sup>d</sup> day of August 1847 on the oath of David Morgan?
