Which was read

On motion by Mr. Stevens, That the bill to prevent the unnecessary accumulation of costs on civil suits have a second reading; Mr. Kilgour moved to postpone the same. Determined in the negative.

The bill was then read the second time, passed, and sent to the senate.

The speaker laid before the house a communication from the executive, in compliance with the order of this day; which was read.

The bill to reduce the salary of the examiner general on the eastern shore, was read the second time.

On motion by Mr. Eccleston, the blank was filled up with \$200, passed, and sent to the senate.

The house proceeded to the second reading of the bill for the promotion of internal improvement.

On motion by Mr. Thomas, 'Elkton' was inserted after Cumberland, in the section ordering public notice to be given in the newspapers.

On motion by Mr. Hall, 'Belle-Air' was inserted.

On motion by Mr. Lee, 'Rockville' was inserted.

On motion by Mr. Howard, the word 'ten' was stricken out and 'five' inserted, in the 19th section, which provides that the treasurer shall subscribe for ten thousand shares of the stock of said company.

On motion by Mr. Goldsborough, the word 'one' was stricken out and 'two' inserted in the clause appropriating one hundred thousand dollars.

On motion by Mr. Goldsborough, the words 'drain, embank and render dry and arable the low lands on the margins of such rivers and creeks of the eastern shore of this state, as the board of public works may think proper and recommend, and to' were inserted in the 21st section.

Mr. Hall moved to insert in the amendment the words 'and western shore.' Determined in the negative.

Mr. Thomas moved to insert 'Susquehanna river?' Determined in the negative.

Mr. Stevens moved to insert 'Chester river?' Resolved in the affirmative.

On motion by Mr. Thomas, 'Elk and North East rivers,' were inserted.

On motion by Mr. Thomas, the question was put on inserting 'Sassafiras river.' Determined in the negative.

On motion by Mr. Thomas the question was put, on inserting 'the Chesapeake and Delaware canal.' Determined in the negative.

On motion by Mr. Goldsborough, the words 'contemplated to be made on the low lands situated on the margins of the aforesaid rivers and creeks, or to execute the improvements,' were inserted in the 21st section.

On motion by Mr. Goldsborough, the question was put, That the following be inserted in the same section after the words 'the congress of the United States shall' to wit: 'by law authorise a subscription for not less than ten thousand shares of the capital stock of the eastern section of the Chesapeake and Ohio canal, and shall.' Resolved in the affirmative.
