The clerk of the senate returns the resolution relative to Harris and Johnson's Reports; the resolution relative to the committee to visit the penitentiary; and the resolution relative to printing the laws, severally endorsed 'assented to.'

Also the bill relative to appeal, writ of error and injunction bonds; the bill to protect the breed of fish in the rivers and waters of Anne-Arundel county, severally endorsed will pass with the proposed amendments; which were read.
