Mr. Barne's moved to strike out \$800, for the examiner general, to insert \$600. A division was called for and put on striking out. Determined in the negative.

Mr. Maxcy moved to insert 'for the adjutant-general \$500?' Re-

solved in the affirmative.

The bill was then passed and sent to the senate.
