The order requiring information from the commissioners of the school fund, for Queen-Anne's county, was read the second time and assented EO.

On motion by Mr. Banning, the following resolution was read, as-

sented to, and sent to the senate:

Resolved, That William K. Lamden esq. appointed treasurer for the eastern shore of Maryland, be, and he is hereby required, before he proceeds to execute the duties of his said office, to give bond to the state of Maryland, in the penalty of twenty thousand dollars, with at least two securities to be approved of by the governor and council, for the due and faithful performance and discharge of all the duties of him required as treasurer aforesaid.

Resolved, That John K. B. Emory, esq. late treasurer of the eastern shore of Maryland, be, and he is bereby required forthwith to deliver unto William K. Lamden, esq. of Talbot county, the present treasurer for the eastern shore of Maryland, all monies in the treasury, books of accounts, and other papers appertaining to said treasury.

Mr. Hughlett reports a bill, entitled, Anact for the benefit of Richard Mason, of Caroline county; which was twice read by special order,

passed, and sent to the senate.

Mr. Cockey presents a petition from sundry inhabitants of Frederick county, praying for a lottery to raise a sum of money to complete the Deep Run Woolen Manufactory; referred to Messrs. Cockey, Farquhar and Sappington.

The speaker called Mr. A. E. Jones to the chair.

On the second reading of the rules, on motion by Mr. Teackle, the

following were adopted after 2d rule.

3. Immediately after the reading of the proceedings of the preceding day, the clerk shall announce the bills ready for a second reading, and the orders of the day.
