

Which was twice read, the resolution therein contained assented to, and sent to the senate.

On motion by Mr. Saulsbury, Leave given to bring in a bill, entitled, An act to regulate the fees of justices of the peace in this state. Ordered, That Messrs. Saulsbury, Keene and Douglas, report the same.

Mr. Tyson obtains leave a bring in a bill to be entitled, An act supplementary to an act, entitled, An act relating to the city of Baltimore, passed December session 1817. Ordered, That Messrs. Tyson, Howard and Shower, report the same.

Mr. Tyson presents a petition from Ann Cowan; Mr. Thomas presents a petition from James M'Cracken; Mr. Boon presents a petition from Wm. Crane; severally referred to the committee on pensions and revolutionary claims.

Mr. Millard presents a petition from Thomas Huitt, for support; referred to the committee on similar petitions.

The resolution relative to the sale of the government house, was read the second time Mr. Gantt moved to insert the words, "state house and public offices." Determined in the negative.

Mr. Thomas moved to refer the same to the 1st of April? Determined in the negative.

Mr. Millard moved to amend it, so as to make the sale on a credit of 13 years? Determined in the negative.

Mr. Farquhar moved to fill the first blank with \$100,000? Resolved in the affirmative.

Mr. Thomas moyed to add the words "for cash." Resolved in the affirmative.

Mr. Gantt moved to add the words; "to some orderly, well disposed person or persons," after the words "to let the premises."

When Mr. Willson moved to refer the resolution to the next general assembly? Resolved in the affirmative.

Mr. Howard presents a petition from David Martin for a special act of insolvency; referred to the committee on similar petitions.

Mr. Ennalls obtained leave to bring in a bill, entitled, An act for the purpose of securing costs to plaintiffs in all cases where they may arise in the legal prosecution of his or their just claims. Ordered, That Messrs. Ennalls, Brohawn, Douglas, Garner and Edelen, report the same.

Mr. Speed obtained leave to bring in a bill to be entitled, An act to ascertain and settle the law relative to proceedings under the several acts of forcible entry and detainer, and under the act of 1793, chapter 43. Ordered, That Messrs. Speed, Howard, M'Culloh, Ridgaway and Brooke, report the same.

Mr. Stevens presents a petition from the citizens of Church Hill, and its vicinity, praying that the donation given to Centreville academy, may be divided between that and the Church Hill academy; referred to Messrs. Stevens, Sudler and Ridgaway.

The bill for the relief of the executors, in Maryland, of William Murdock of London, deccased; and the bill to authorise the keeping of gates on the public road therein mentioned in Montgomery county; were severally read the second time and passed.
