The resolution relative to the records of Talbot county court, was

read the second time, assented to, and sent to the senate.

On motion by Mr. Duvall, the following message was read, assented to, and sent to the senate:

By the House of Delegates, Jan. 9, 1826.

Gentlemen of the Senate,

The governor elect having arrived at the seat of government, we propose, with the concurrence of your honourable body, that a joint committee be appointed to wait on him this day, and request his attendance in the senate chamber to qualify according to the constitution and form of government.

We have named Messrs. Duvall and Grubb on the part of this house, to be associated with such gentlemen as may be appointed in the senate.

Mr. Cockey obtained leave to bring in a bill, entitled, An act to incorporate the Westminster school in Frederick county, and for other purposes. Ordered, That Messrs. Cockey, Farquhar and Sappington, report the same.

On motion by Mr. Goldsborough, he was excused from serving on the committee of ways and means, and the speaker appointed Mr. Sewell

in his place.

Mr. Stevens obtained leave to bring in a bill, entitled, An additional supplement to the act relating to negroes, and to repeal the acts of assembly therein mentioned. Ordered, That Messrs. Stevens, Hall, Carner, Arnold E. Jones and Williams, report the same.

Mr. Cockey reports a bill, entitled, An act respecting the Union

Wool Manufactory.

Mr. Merrick presents a memorial from sundry inhabitants of Washington county, praying that the constitution may be changed so as that the senate, the county clerks, registers of wills, and the judges of the levy courts, may be elected directly by the people.
