


Know all men by these presents, that I Richard Ridgely of the city of Annapolis in the State of Maryland, owing and standing Justly indebted to Ann Ridgely of the city and State aforesaid in the sum of eight hundred dollars in consideration thereof and of the further sum of one dollar to be in hand paid by the said Ann Ridgely, at and before the sealing and delivery of these presents, have bargained and sold and by these presents do bargain and sell unto the said Ann Ridgely all my household and kitchen furniture of every description, now being in my dwelling house in the city of Annapolis. To have and to hold the said household and kitchen furniture to the said Ann Ridgely, her executors administrators or assigns. Provided nevertheless, if the said Richard Ridgely shall pay to the said Ann Ridgely the said sum of eight hundred dollars with Interest due as aforesaid, within three months from the date hereof, then these presents to be void, otherwise of full effect. In witness whereof, I have hereunto set my hand and affixed my seal, this twenty eight day of November Eighteen hundred and twenty nine.

Know all men by these presents that I Richard Wells of Anne Arundel County and the State of Maryland for and in consideration of the sum of seventy five dollars current money to me in hand paid by Jeremiah Wells of Prince Georges County and State aforesaid at or before the sealing and delivering of these presents the receipt whereof I the said Richard Wells do hereby acknowledge have granted, bargained and sold and by these presents do grant, bargain and sell unto the said Jeremiah Wells his executors, administrators and assigns one bay horse now in my possession. To have and to hold the said Horse to the said Jeremiah Wells his executors administrators and assigns forever; and I the said Richard Wells for my self my heirs executors and administrators, the aforesaid Horse to the said Jeremiah Wells his executors, administrators and assigns, against me the said Richard Wells my executors and administrators and against all and every person and persons whomsoever, shall and will warrant, and forever defend by these presents. Provided nevertheless that I the said Richard Wells shall pay and satisfy to the said Jeremiah Wells or to his executors, administrators or assigns the sum of Five dollars current money with Interest for the same on or before the first day of December Eighteen hundred and thirty one, then this Bill of Sale, and every matter and thing therein
