 all of which said goods and chattels are now in my possession. To have and

 administrators and assigns forever; And I the said Gideon Pearce for myself,
 my heirs, executors and administrators, the aforesaid goods and chattels to the
 said John S Selby his executors, administrators and assigns, against me the said
 Gideon Pearce, my executors and administrators and against all and every person
 and persons whomsoever, shall and will warrant and forever defend by these presents
 Provided nevertheless, that in case I the said Gideon Pearce shall pay and
 satisfy to the said John S Selby or to his executors, administrators or assigns, the
 said sum of Six hundred and forty one Dollars and eighty three cents current
 money, (without Interest,) on or before the ninth day of March in the year
 Eighteen hundred and thirty one; then this Bill of sale and every matter and
 thing therein expressed, shall be void and of none effect, it being the true intent
 and meaning thereof, that the said Goods and Chattels are mortgaged by me
 the said Gideon Pearce to secure to the said John S Selby the payment of the
 aforesaid sum of six hundred and forty one dollars and eighty three cents current
 money, (without Interest thereon) at the time above stipulated. In witness
 whereof, I the said Gideon Pearce have hereunto set my hand and affixed my seal
 this ninth day of April in the year eighteen hundred and thirty.
