 save harmless the said Margaret Keall on account of the said now and the said last mentioned
 sums of money so due and owing as aforesaid has agreed to execute these presents now this
 Indenture witnesseth, that the said Ephraim W Keall for and in consideration of the
 premises and for and in consideration of the sum of five dollars current money to him in
 hand paid by the said Margaret Keall at or before the sealing and delivery of these
 presents the receipt whereof the said Ephraim W Keall doth hereby acknowledge
 thereof and therefrom doth acquit release exonerate and forever discharge the said
 Margaret Keall her heirs Executors and administrators and every of them by these presents
 hath granted bargained and sold and by these presents doth grant bargain and sell
 unto the said Margaret Keall her Executors administrators and assigns all and singular
 the goods furniture and other personal property hereinafter mentioned and expressed
 that is to say four horses two ploughs four Cultivators one Rigg and harness four hundred
 pounds of meal one barrel of whiskey one barrel of molasses one barrel of sugar two plough
 shares one cow shell one wheel Barrow one dozen hoes and one team of horses and to
 hold all and singular the said goods and personal property hereinafore granted
 bargained and sold or mentioned or intended to be unto the said Margaret Keall
 her Executors administrators and assigns to the only proper use and behoof of the
 said Margaret Keall her Executors administrators and assigns forever provided
 always and these presents are upon the condition that if the said Ephraim W Keall
 his Executors or administrators shall do and well truly pay or cause to be paid unto the
 said Margaret Keall her Executors administrators or assigns the said sums so
 mentioned as aforesaid with interest for the same on or before the first day of
 April in the year eighteen hundred and forty three then and in such case these presents
 and every matter and thing herein contained shall cease determine and be utterly
 void to all intents and purposes anything herein contained to the contrary thereof
 in any wise notwithstanding In witness whereof the said Ephraim W Keall has
 hereunto set his hand and affixed his seal the day and year first above written
