 administrators or assigns hath granted bargained and sold release and confirm
 and by these presents doth grant bargain and sell release and confirm unto the said
 William Jones his heirs and assigns all the property in the Schedule hereunto
 annexed that is to say, one Dark Brown filly about three years old and one
 Colt about two years old, one Brown Cow one red Cow one red calf one clock
 five feather Beds and Covering pillows & Bolsters five Bedsteads two chairs two
 tables one Bureau one Carpet Rug & two China one doz knives & forks one doz
 plates & doz silver tea spoons one Stone three paw andirons one fire fender and
 Shovel & Longs one Wash Stand four pitchers & bowls and all the rest of
 household furniture and being now in a certain messuage or tenement situate
 the Village of Bristol and in the same County and State as above and now in
 the occupation of the said Benjamin Jones and also all the Interest Right
 title and claim of the said Benj^r & Jones Books of accounts and also the
 said Benjamin Jones interest right title and claim to the stock of goods wares
 merchandise and accounts being in a certain messuage or tenement in the
 before named Village County and State and now in the possession of the
 said Benj^r & Jones the above named stock of goods groceries hardware
 crockery wear ploughs nails &c and the said Benj^r & Jones interest of the above
