 Executors and administrators and against all and every person and persons whom-  
 soever shall and will warrant and support defend by these presents Provided  
 nevertheless that the said Dennis H. Butler shall pay and satisfy to  
 the said Chasly & Gosnell or to their Executors administrators or assigns the said  
 sum or sums of money due herewith with Interest on the same over before the first of  
 August next ensuing, then this bill of sale and every matter and thing therein  
 expressed shall be void and of no effect it being the true intent and meaning  
 thereof that the said Corn is mortgaged by and to the said Dennis H. Butler to
