


For and in consideration of the ~~sum~~ of five dollars premises and for and in consideration of the premises sum of five dollars current money to him in hand paid by the said Stevens Lambill at or before the sealing and delivery of these presents, the receipt whereof the said Passmore McCullough acknowledges and thereof and therefrom doth acquit, release, exonerate and forever discharge the said Stevens Lambill his heirs, executors, administrators and every of them by these presents both granted, bargained and sold and by these presents doth grant, bargain and sell unto the said Steven Lambill his executors, administrators and assigns all and singular the goods, furniture and household stuff, hereinafter particularly mentioned and expressed: that is to say, five feather beds, two bedsteads, two pair of blankets, two quilts, one pair of sheets, twelve chairs, three wash stands, five basins and pitchers, six chambers, one small mahogany stand, one small mahogany table, one clock, two looking glasses one english carpet one pair of fancy window curtains, two small cherry tables, one large pine table, one pair of andirons, one fender shovel and tongs, pair of wipers a lot of carpeting and rods for steps, one settee, one pair of iron andirons, three kegs, three large jugs, four decanters, three wipers, seven tumblers, one bureau, one high post bedstead, three old chairs, one black and white cow, and one yoke of Oxen and or cast. To Have and to hold all and singular the said good furniture and household stuff hereinbefore granted, bargained and sold or mentioned or intended to be unto the said Steven Lambill his executors, administrators and assigns to the only proper use and behoof of the said Steven Lambill his executors, administrators and assigns forever. Provided always and these presents are upon this condition, that if the said John C. Benjamin, for whom the said Steven Lambill has become surety in the replevin bond aforesaid, shall well and truly prosecute his writ of replevin in some Record County Court with effect, and also shall and will return ~~to~~ the goods and chattels to the said Anne Lambill if the same be adjudged, and in all things stand to abide by perform and fulfil the judgment in the premises of the said Anne Record County Court, so as to law harmless the said Steven Lambill as security as aforesaid, then and in such case these presents and every matter and thing herein contained, shall cease, determine and be utterly void to all intents and purposes anything contained to the contrary thereof in anywise notwithstanding.
