Planter was summons to answer unto ~~Summons~~ & S. of a plea that he render him the full and just summe of Six hundred pounds of good Tobacco clear from trash ground leaves & small Dull Tobacco with Cash to contain the same of the value of Six pounds Sterling money which from him he unjustly claims &c. And whereupon the afof ptt. By Thomas Bowne his attly Saith that Whereas the afof D. off the Twenty-seventh day of August in the Year of our Lord Christ one thousand Seven hundred and Seventy one all. parishes in Kent County within the jurisdiction of this Court by his certain Oath obligatory which he then laid D. off sealed with this Seal and as his deed delivered heremto Court brought the date whereof with the same day and year afof bound himself to pay unto the afof ptt. the afof full and just summe of Six hundred pounds of good Tobacco clear from trash ground leaves & small Dull Tobacco with Cash to contain the same of the said value of Six pounds Sterling money when hereunto required yet the afof D. off altho often required the afof sume of Six hundred pounds of Tobacco to the said ptt hys not paid but that to him to render or pay further to hath denied andfull doth deny and unjustly claims to the damage of him the said ptt. Two & two pounds Sterling money and thereupon lie brings Suit &c.

And the afof ptt. By Thomas Bowne his attly Saith that the ptt. is not an inhabitant of this County prays that he may be taken as surety for D. off which is granted and the afof Thomas Bowne comes into Court and saith that if the afof D. off shall appear to the above Action and the ptt. should be cast in the same that then he will pay the same D. off all Cost occurring on the same if the ptt. pay it not himself.

And the afof D. off being called came and the afof ptt. By his attly pray that the said ptt. may give speciall Baile to the afof Action which is granted After whereupon the afof D. off came into Court and said he did acknowledge himself as speciall Baile in the afof Action and doth undertake for the afof D. off the payment of the debt afof & Cost theron occurring if the same D. off shall be cast with the same And the Consideration shall not be less than to pay himself to the Custody to the Sheriff of said County delivere or that the afof D. off, or his like party of the afof D. off shall not render &c.

And the afof D. off in his proper person appears to the above Action and saith that he cannot pay the debt afof & Cost theron occurring but that the writing obligatory afof mentioned in his afof Deed and that he oweeth unto the said ptt. the afof summe of Six hundred pounds of Tobacco the Debt afof and is willing that judgment shal be entered for the sume & Cost theron occurring. Wherefore it is ordered by the Court here by. the Twenty first day of August Anno Domini One thousand Seven hundred and Eighteen That the afof ptt. Bennett Sowe do recover against the said D. off William Burrows o. v.
