And whereupon the ^{ap} p^t by Thomas Borne his atty South that whereas the ^{ap} p^t the Twentieth - Seventh day of August in the Year of our Lord Christ one Thousand Seven hundred and Seventeen did ^{the} Defendant ⁱⁿ Kent County within the jurisdiction of this Court by his Certain Bill Obligatory which he the said ^{ap} p^t sealed with his Seal and as his deed delivered herewith Court brought the date whereof in the Same day and year as bound himself to pay unto the ^{ap} p^t the full and just Summe of Six hundred pounds of good Tobacco clear from trash ground Leaves & Small Dull Tobacco with Cash to contain the Same of the value of Six pounds Sterling money when thereunto required yet the said ^{ap} p^t hath not paid but that to him to render or pay further hath denied and still doth deny and unjustly detain to the Damage of him the said ^{ap} p^t Twelve pounds Sterling money and thereupon he brings Suite &c.

And the ^{ap} p^t by Thomas Borne his atty South that the ^{ap} p^t is not an Inhabitant of this County prays that he may be taken as Surety for Cash which is granted And the ^{ap} p^t Thomas Borne comes into Court and South that if the ^{ap} p^t shall appear to the above ^{ap} p^t and the ^{ap} p^t should be cast in the Same that then he will pay the Same ^{ap} p^t all ^{ap} p^t accruing on the Same if the ^{ap} p^t pay it not himselfe
