Kent County & William Cook of Kent County planter stands attached to answer unto William Frisby late Sherriff of Kent County of a plea of trespass of the case. And it is recited the ap ptt by Thomas Bowne his atty complains that whereas the ap Debt the Liberty third day of January in the year of our Lord Christ one thousand seven hundred and fourteen at St. Pauls parish in Kent County within the jurisdiction of this Court was indebted unto the ap ptt in the sume of one hundred and eight pounds of Merchantable Tobacco for the like sume of Tobacco for one levy of one Taxable then and there due from the said Debt to the said ptt. the said ptt then and there being Sherriff of Kent County and the sume of thirty pounds of Merchantable Tobacco for one American then and there due from the said Debt to the ap ptt. the said ptt then and there being Sherriff of Kent County and so thereof being indebted the ap Debt in consideration thereof then and there upon himself assumed and to the said ptt then and there last mentioned faithfully promised that he the said Debt the ap Sume of one hundred and eight pounds of Merchantable Tobacco and so thirty pounds of Merchantable Tobacco unto the said ptt when the same required would well and truly pay and content and shall likewise also the ap Debt afterwards by the twenty third day of January in the year of our Lord Christ one thousand seven hundred and fifteen at St. Pauls parish in Kent County within the jurisdiction of this Court was indebted unto the ap ptt in the sume of one hundred and fifty two pounds of Merchantable Tobacco for the like sume of Tobacco for one levy of one Taxable then and there last said due from the said Debt to the ap ptt. The ap ptt then and there last said being Sherriff of Kent County and so thereof being indebted the ap Debt in consideration thereof then and there last mentioned upon himself assumed and to the said ptt then and there last
