last mentioned faithfully promised that he the said Deft. the app Summe of one hundred and fifty five pounds of Merchantable Tobacco unto the said ptt when thereunto required would well and truly pay and Content And that whereas also the app Deft. afterwards by the Twenty third day of January in the Year of our Lord Christ One thousand Seven hundred and Sixteen at Spauls parish in Kent County within the Jurisdiction of this Court was indebted unto the said ptt in the Summe of Two hundred and fourteen pounds of Merchantable Tobacco for the like Summe of Tobacco for one dovy of one Jacable then and there last mentioned and from the said Deft. unto the app ptt the app ptt then and there last mentioned being Sheriff of said County and so thereof being indebted the app Deft. in the Summe thereof then and there last mentioned upon himself assumed and to the said ptt then and there last mentioned faithfully promised that he the said Deft. the app Summe of Two hundred and Twenty one pounds of Merchantable Tobacco unto the said ptt when thereunto required would well and truly pay and Content Nevertheless the app Deft. in his promises and Assumptions as in forme app made as to the app Several Sums of Tobacco which in the whole amounts unto the Summe of Two hundred and fourteen pounds of Merchantable Tobacco little regarding but plotting and fraudulently intending him the said ptt in that behalf craftily and Subtly to deceive and defraud the app Summe of five hundred and fourteen pounds of Merchantable Tobacco to the said ptt altho afterwards by the fifth day of October in the Year of our Lord Christ One thousand Seven hundred and Seventeen and often after at the parish County and Jurisdiction app was thereunto hath not paid nor made Content for the Same but that to him to pay or Content for the Same hitherto hath denied and still doth deny to the damage of him the said ptt One thousand and Twenty eight pounds of Merchantable Tobacco and thereupon he brings Sute &c.

And the app Deft. in his proper person appeared to the above Curon and said that he cannot gain say the Curon of Mr. but that he oweth unto the said ptt the app Summe of Two hundred and fourteen pounds of Tobacco and is willing that Judgment should be entered for the Same and Cost thereon accruing: Therefore it is ordered by the Court here by this twenty first day of August Anno Domini One thousand seven hundred and Eighteen that the app ptt William Frisby do recover against the app Deft. William Cook as well the app Summe of Two hundred and fourteen pounds of Tobacco Damages as also the Summe of Three hundred and Twenty one pounds of Tobacco Cost by the app ptt about his Sute in this behalfe expended and by the Court here of his appnt adjudged and the said Deft. in moray &c.
