agreed upon him selfe assumed and to the said Benjamin they and there
 faithfully promised that he the said Richard all such sumes of tobacco at the
 aforesaid Benjamin had expended or laid out in and about the said estate together with
 the said two thousand two hundred and eighty pounds of tobacco after he
 the said Benjamin should have proved the said two thousand five hundred
 and eighty pounds of tobacco to the said Benjamin which there unto required
 would well and truly pay and content and the aforesaid Benjamin indeed saith
 that the tobacco to the said Benjamin had expended and paid out in and
 about the said estate amounted unto the sume of one hundred and seventy
 pounds of tobacco and that the said Benjamin afterwards vj. the twenty
 second day of March in the year of our Lord Christ One thousand seven hundred
 and sixteen at Cyster Town in Kent County aforesaid in the Court of Open Court
 before the aforesaid Justices in the said Court judicially setting in the records of
 the same Court did cause the said estate to be valued agreed as by the records of
 the same Court here remaining fully appears of all which two thousand five
 hundred and eighty pounds of tobacco proved as abovesaid one hundred and seventy
 pounds of tobacco left the said Richard by the aforesaid Benjamin afterwards
 vj. the aforesaid twenty second day of March in the year of our Lord Christ
 in the year of our Lord Christ One thousand seven hundred and fifteen at St. Pauls
 Parish in Kent County aforesaid within the jurisdiction of this Court was impled onto the said
 Richard in the sume of one hundred and seventy pounds of tobacco a certain
 cost of estate and the sume of two thousand five hundred and eighty pounds
 of tobacco for wor seruice done by the aforesaid Richard for the aforesaid and to the
 proper use and behoof of the aforesaid Richard before that time in the parish County
 and jurisdiction aforesaid done & performed and so thereof being impled the aforesaid
 In Consideration thereof upon his selfe assumed and to the said Benjamin
 there and there faithfully promised that the said Richard the aforesaid sume of one
 hundred and seventy pounds of tobacco and no more tobacco due for the
 services done and performed in East mentioned as aforesaid proofs should appear
 to the said Richard to be due to him in the said estate when the same so required
 would well and truly pay and content and the aforesaid Richard saith that
 the aforesaid twenty second day of March in the year of the sume of two thousand
 five hundred and eighty pounds of tobacco do by the Deth of the said Richard before
 Nathaniel Lyon and his associates their Justices of the said County and jurisdiction aforesaid
 lord proprietor for the said Court in the said estate in the County and jurisdiction aforesaid
 judicially setting taken was legally proved and appeared due to the said Richard
 en by the records of the same Court here remaining fully appears and of which the
 said Richard the twenty third day of March in the year aforesaid at the Parish County &
 jurisdiction aforesaid notice was had whereas also the aforesaid Richard afterwards vj. the
 aforesaid twenty second day of March in the year aforesaid at the parish County and jurisdiction
 aforesaid was impled unto the aforesaid Richard the sume of two thousand five hundred and
 eighty
