Deft. the first day of April in the year of our Lord Christ one thousand seven hundred and eighteen a. bails parit in Kent County within the Jurisdiction of this Court was indebted unto the ap. plt. in the Summe of five hundred and forty five pounds of Merchantable Tobacco for the like Summe of Tobacco for Cts. due from the ap. Deft. to the ap. plt. and so thereof being indebted the ap. Deft. in Consideration thereof and there upon himself assumed & to the said plt. then and there faithfully promised that he the said Deft. the ap. Summe of five hundred and forty five pounds of Merchantable Tobacco unto the said plt. when thereunto required would well and truly pay Content Nevertheless the ap. Deft. his promise and assumption ap. in form ap. made little regarding but plotting and fraudulently intending him in that behalfe craftily and subtilly to deceive and defraud the ap. Summe of five hundred and forty five pounds of Tobacco unto the said plt. altho he the said Deft. afterwards viz. the second day of April in the year ap. and often after at the parish County & Jurisdiction ap. was thereunto required hath not paid nor made Content for the same but that to him to pay or make Content for the same be that to him to pay or make Content for the same neither hath deriged & still deny deny to the Damages from the said. 17 one thousand pounds of Tob. and thereupon he brings Suite &c.
