and his associates then Justices of the Said Lord the King of the Court and County of and upon the plea aforesaid recovered against the aforesaid John Cochran as well the aforesaid sum of five hundred pounds of Tobacco Debt as also the sum of three hundred fifty two pounds of Tobacco Costs which were to the Said Renato Smith in the Said Court here were adjudged for his damages which he had by occasion of detaining of his Debt aforesaid hereby he is convicted Sustained as by the Record & process thereof in the same Court of his Said Lord the King before the Said Justices here Likewise residing both manifestly appear yet the aforesaid John Cochran his body to the Custody of the Sheriff of Said County did not deliver nor to the aforesaid Renato Smith the debt and Cost aforesaid Satisfied as by the Information of the aforesaid Renato Smith (and Receive i.e. the Lord proprietars Receive and we being willing that those things in the aforesaid Court before the aforesaid Justices should be rightly acted we Command you that by good and lawful men of our Party with you make known to the aforesaid Nicholas Waterman that he do and appear before the Justices of our next County Court to be held at our Court house in the Town of Chester in Said County on the third Instant June next to show cause if any he have or know to say wherefore the aforesaid Renato Smith wherefore the aforesaid five hundred pounds of Tobacco Debt aforesaid and the sum of three hundred fifty two pounds of Tobacco Damages appeared by him in forme aforesaid Recognized of his Lands and Chattells to be made or the aforesaid John Cochran to render himselfe ought not according to the forme of the Recognition appeared of to him it shall seem Expedient And have you there the names of those by whom to him you make known and also this writ with the Seal of the High Court Chief Justice Justice of our Said Court this 25 day of March in the third year of his Lordships Dominion in Anno Domini 1717
