With Glases for the Sum of Eighteen pounds of Merchantable Tobacco and one fapound box for the Sum of twenty four pounds of Merchantable Tobacco in the whole amounting unto the Sum of Three Thousand Eight Hundred and forty two pounds of Merchantable Tobacco then and there upon himselfe assumed and to the said p<sup>t</sup> then and there faithfully promised that he the said Deft<sup>r</sup> the ap<sup>t</sup> Sum of Three Thousand Eight Hundred and forty two pounds of Merchantable Tobacco unto the said p<sup>t</sup> when the same required would well and truly pay and Content and that whereas also the ap<sup>t</sup> Deft<sup>r</sup> afterwards by the ap<sup>t</sup> Twentieth day of February in the Year of our Lord Christ one Thousand Seven hundred and sixteen at St. Pauls parish in Kent County within the Jurisdiction of the Court in Consideration that the ap<sup>t</sup> p<sup>t</sup> at the like special instance and request of the ap<sup>t</sup> Deft<sup>r</sup> had then and there last mentioned Sold and delivered unto the ap<sup>t</sup> Deft<sup>r</sup> and to the proper use and behoofe of the ap<sup>t</sup> Deft<sup>r</sup> the divers Goods Merchandises in an Act hereto annexed sett forth upon himselfe assumed and to the said p<sup>t</sup> then and there last mentioned faithfully promised that he the said Deft<sup>r</sup> so much Merchantable Tobacco as the ap<sup>t</sup> last mentioned Goods and Merchandises Sold and delivered as last said at the time of the Sale and delivery thereof at reasonable rates and prices were worth and amounted to unto the said p<sup>t</sup> when the same required would well and truly pay and Content and the ap<sup>t</sup> p<sup>t</sup> indeed saith that the ap<sup>t</sup> last mentioned Goods and Merchandises Sold and delivered as last said at the time of the Sale and delivery thereof at reasonable rates and prices were worth and amounted unto the Sum of Three Thousand Eight hundred and forty two pounds of Merchantable Tobacco in manner as in said Act sett forth of which the said p<sup>t</sup> then and there last mentioned had notice Never the less the ap<sup>t</sup> Deft<sup>r</sup> his severall promises and assumptions ap<sup>t</sup> in forme ap<sup>t</sup> made as to the ap<sup>t</sup> severall Sums of Tobacco which in the whole amounts unto the Sum of Seven Thousand Six hundred and eighty four pounds of Tobacco he hath not divided nor in anywise kept but altho' he the said Deft<sup>r</sup> hath paid and satisfied unto the ap<sup>t</sup> p<sup>t</sup> one thousand nine hundred and ninety seven pounds of Tobacco of the ap<sup>t</sup> Seven thousand Six hundred and eighty four pounds of Tobacco part yet the ap<sup>t</sup> Deft<sup>r</sup> his promises and assumptions as to the Sum of five thousand six hundred and eighty seven pounds of Tobacco of the ap<sup>t</sup> Sum of Seven thousand Six hundred and eighty four pounds of Tobacco residue little regarding but plotting and fraudulently intending him the said p<sup>t</sup> of the ap<sup>t</sup> Sum of five thousand six hundred and eighty seven pounds of Tobacco craftily and subtilly to deceive and defraud the ap<sup>t</sup> Sum of five thousand six hundred and eighty seven pounds of Tobacco to the said p<sup>t</sup> altho' afterwards by he the said Deft<sup>r</sup> the fourth day of November in the Year of our Lord Christ one thousand Seven hundred and seventeen and often after at the parish County and Jurisdiction ap<sup>t</sup> was thereunto required
