day of November in the fourth year of his Lordships Dominion & that he
cause to come John Haynes late of Lower South Safras hundred Labourer
Servt to Rachel Medford of the said County Widow if he should be found in his
Bailywick that all Escapes and Delays be set apart he be and appear
before the Justices of our next County Court to be held at our Court house in the
Town of Chester in said County to Answer unto a certain Indictment found
against him for committing fornication with a certain Rachel New-sam &
thereby did begett a Child on her Body & And that he have then and there
the said precept etc. All which said next Court by the Seventeenth day
of March the same year last mentioned the day of return of said precept
came Simon Wilmer Gent high Sheriff of said County and made return
thereof in these words thereon endorsed as follo: by Summons of Simon
Wilmer Sheriff

and the afof John Haynes being called came and in his proper person appeared
to the afof Indictment and the same being read to him saith he cannot gainsay the
Indictment afof nor say that he is guilty as above and submits to the same
Therefore it is ordered by the Court here by this nineteenth day of
March Anno Domini One Thousand Seven hundred and Eighteen that the
afof John Haynes to receive on his bare back twenty one lashes well laid
on his bare back for the offence afof and also pay the sum of three hundred
thirty eight pounds of tobacco & all accuring on the premises afof

It is Considered by the Court here by the same day last mentioned
that the Sheriff of said County take the afof John Haynes into his Custody and
put to the public whipping post and there receive as in the judgment afof
and then to bring him into Court againe after which the same day last
mentioned came Simon Wilmer Gent high Sheriff of said County and made
return of his precept as follo: by all means accounted of Simon Wilmer Sheriff

Rachel Medford witness of the afof John comes into Court and saith She will
take the Child that was begott between the afof John Haynes and the afof
Rachel New-sam mentioned in the afof Indictment and keep the same from
the County to which the Court orders that the afof Child be sent with the afof
Mrs Rachel Medford and to serve her till it comes to age
Ordered by the Court here that the afof John Haynes be delivered up at
the Expiration of the time
