Sott forth upon himselfe assumed and to the Said p^t. then and there faithfully promised that he the Said Deft. of a^d one pound Currant money Credited as a^d and also so much Currant money of America as the a^d Goods and Merchandizes Sold & delivered as a^d at the time of the Sale & delivery thereof at reasonable rates & prices were worth and amount to unto the Said p^t. when thereunto required would well and truly pay & Content and the a^d Deft. indeed Saith that the a^d Goods & Merchandizes Sold & delivered as a^d at the time of the Sale & delivery thereof at reasonable rates & prices were worth & amounted unto the sume of Nine pounds fifteen Shillings & five pence Currant money of America in manner as in the a^d Account Inclosed of which the a^d Deft. had then & there a^d notice Nevertheless the a^d Deft. his promise and assumption a^d Informe a^d made as to the a^d severall Sumes of money in y^e whole amounting to ten pounds fifteen Shillings and five pence Currant money of America little regarding but fraudulently intending y^e Said p^t. in that behalf to deceive and defraud the a^d Ten pounds fifteen Shillings & five pence to the Said p^t. altho' on the third day of April and often after Anno Domini Seventeen hundred & Sixteen he was at the parish a^d in Kent County a^d within y^e Jurisdiction a^d thereto required heath not paid nor made Content for the Same but that to pay or Content the Deft. hitherto hath denied and yet denye to the damage of the Said p^t. Twenty pounds Currant money of America and thereupon he brings Suit &c.
