Twentieth day of March Anno Domini one Thousand Seven hundred and Eighteen That the ap^{pl}ts^{ts} William Carney have an Attachment against the goods and Chattells Rights and Credits of the ap^{pl} Richard Lee for the ap^{pl} Sum of two pounds Eight Shill and three pence Stere money Damages and also the Sum of two hundred Seventy Eight pounds of Tobacco by the ap^{pl} J^{ts} J^{ts} his Lie in this behalfe expended &c

John Falconer Comended it was to the Sheriff of Kent County the twenty second day of November in the fourth Year of his Lord Ships Dominion &c That he take John John Lovegrove Lovegrove of Kent County Cordwainer if he should be found in his Bailwicks and him safe keep so that he have his body before his Lord Ships Justices of the next Court to be had at our Court house in the Town of Dover in said County to answer unto John Falconer and Company March of a plea of Trespas upon the Case and that he have then and there the said writ &c. At which said next Court viz. the seventeenth day of March the same year last mentioned the day of return of said writ came Simon Wilmer Gent. high Sheriff of said County and made return thereof in these words thereon endorsed as folo viz. For parsons Wilmer Sher and a Declaration being filed upon said writ issued forth and a Copy thereof served thereunto according to Act of Assembly in such Cases made was as folo viz. Kent County to John Lovegrove of Kent County Cordwainer stands attached to answer unto John Falconer and Company March of a plea of Trespas upon a Case And thereupon the ap^{pl} J^{ts} by Thomas Bourne their attorney Complain that whereas the ap^{pl} Deft the fourth day of June in the Year of our Lord Christ one Thousand Seven hundred and Seventeen at S. Pauls Parish in Kent County within the Jurisdiction of this Court in Consideration that the ap^{pl} J^{ts} at the Special Justice and Request of the ap^{pl} Deft had then and there by Samuel Vaus their agent and Factor sold and delivered to the said Deft to the proper use and behoofe of the ap^{pl} Deft the divers Goods and Merchandises in an Act. herunto annexed set forth at the rates and prices in the said Act. Shewen amounting to Two hundred and forty and two pounds and a half pence of Merchantable Tobacco upon himself assumed and to the said J^{ts} then and there faithfully promised that he the said Deft the ap^{pl} five hundred and forty and two pounds and a half pence of Merchantable Tobacco to the said J^{ts} when thereunto required would well and truly pay and Content and that whereas also the ap^{pl} Deft afterwards viz. the fourth day of June in the Year of our Lord Christ one Thousand Seven hundred and Seventeen at the Parish County and Jurisdiction ap^{pl} in Consideration that the ap^{pl} J^{ts} at the like Special Justice and request of the ap^{pl} Deft had by the hands of Samuel Vaus their agent and Factor then and there last mentioned sold and Delivered to the said Deft to the proper use of the said Deft the divers Goods and Merchandises in an Act. herunto annexed Specifically set forth upon himself assumed and to the said
