and the app Deft being called came and the app by her app ally prays that the app Deft may give special bail to the app which was granted after which John Rogers and William Browne both of said County here in Court cometh and they jointly and severally acknowledge themselves as special bail in the app and they and either of them do undertake the payment of the app debt and cost on the same if the Deft shall be cast in the same and the condemnation shall not be set aside nor unwise to the Custody of the Sheriff of said County deliver or that the app John Rogers & William Browne or either of them the body of the said Deft shall not render &c.

and the app Deft in his proper person appears to the app and saith that he cannot pay the same nor but that the writing obligatory above mentioned is his act and deed and is willing that Judgment shall be entered for the same and cost thereon according to the law &c. it is ordered by the Court here on this twentieth day of March Anno Domini One thousand seven hundred and eighteen that the app Margaret Browne Executrix of the app Peregrine Browne dec. Recover against the said Deft Edward Rogers as well the app sum of four thousand three hundred and sixty pounds of Tobacco Debt as also the sum of four hundred and fifteen pounds of Tobacco lost by the app app about her sute in this behalfe expended and by the Court here of his assent adjudged and the said Deft in money &c.
