 Jurisdiction a^{pp} did upon herselfe assume and to her said p^{tt} then and there faithfully
 promise that she the said D^{eff} the said Sum of Six hundred pounds of Tobacco to
 the said p^{tt} when she should be therunto required would well and truly content
 and pay and whereas the a^{pp} p^{tt} & D^{eff} the day and Year a^{pp} at the parish County
 and Jurisdiction a^{pp} together and between themselves did account of and concerning
 divers Sumes of Tobacco from her the said D^{eff} to him the said p^{tt} then and there
 due and unpaid and upon that Account the said D^{eff} was then and there found in
 arrearages towards the said p^{tt} in y^e said Sum of Six hundred pounds of Tobacco
 and being so found in arrearages did then and there upon herselfe assume & to
 the said p^{tt} then and there faithfully promise that she the said D^{eff} the said
 Sum of Six hundred pounds of Tobacco to the said p^{tt} when she should be
 therunto required would well and truly pay and content Nevertheless the said
 D^{eff} her promises & assumptions a^{pp} in form a^{pp} made little minding or regarding
 but plotting and fraudulently him the said p^{tt} in this behalf craftily & subtilly
 to deceive & depaied the said several Sumes of Tobacco or any part thereof to y^e
 p^{tt} hath not paid or made Content altho' to do the same the said D^{eff} the
 sixth day of December in the Year a^{pp} at the parish County and Jurisdiction a^{pp}
 and oftner since by the said p^{tt} hath been thereto required but to pay the same
 hath hitherto refused & still doth refuse to the damage of the said p^{tt} one Thousand
 pounds of Tobacco and thereupon he brings Suit a^{pp}

and the a^{pp} D^{eff} a^{pp} proper person appeared to the a^{pp} Court and saying
 that she cannot gainsay the same nor but that she is indebted to the
 a^{pp} p^{tt} the a^{pp} Sum of Six hundred pounds of Tobacco and is willing that
 Judgment shall be entered for the same and a^{pp} thereon accruing Interest
 it is considered by the Court here viz. this twentieth day of March
 Annoq^{ue} Domini One Thousand Seven hundred and Eighteen that the
 a^{pp} p^{tt} William Tower do recover against the said D^{eff} Lucia Harper
 as well the a^{pp} Sum of Six hundred pounds of Tobacco Damages and
 also the Sum of two hundred Eighty one pounds of Tobacco Cost by the
 a^{pp} p^{tt} about his Sute in this behalf expended and by the Court here of
 his a^{pp} sent a^{pp} judged and the said D^{eff} imprisoned
