 Debt hath not paid the app sum of seven hundred and fifty pounds of
 Tobacco in or upon the app tenth day of October which to him the said ptt. in
 or upon the app tenth day of October he the said Debt ought to have paid
 according to the forme and effect of the said Bill by which curren hath accrued to the
 said ptt to have of the app Debt the app sum of two thousand three hundred
 pounds of Tobacco yett the app Debt altho often required the app sum of two
 thousand three hundred pounds of Tobacco to the said ptt hath not paid but
 that to him to render or pay thereto hath denied and still doth deny and
