 he cannot gain say the ptt in his action afd so as afd against him  
 brought nor can say but that the said ptt ought to recover his debt by execution  
 of the premises afd to the sume of two thousand three hundred pounds of Tobacco  
 and off of suite against him which the said ptt does not gain say therefore it is  
 considered by the Justices here the 19 day of August Anno Dom 1719 that the said  
 Philip Kennard recover against the said John Turgg as well the sume of two  
 thousand three hundred pounds of Tobacco his debt afd in forme afd Confessed  
 as also the sume of two hundred forty nine pounds of Tobacco by the Court here  
 adjudged to him for his costs and Charges by him about his suite in this behalf laid  
 out and expensed and the Deft in money £<sup>2</sup>

 pounds of good Sound Merchantable Tobacco well Condition Clear of all manner of  
 trash & ground Leaves in Carque to Containe the same of the Value of six  
 hundred Sterling money which he unjustly detains &

And to recover the afd ptt by Thomas Goume his atty in law  
 that whereas the afd Deft the thirteenth day of July in the year of our Lord Christ  
 one thousand seven hundred and seventeenth afd Sparks Parish in Kent County  
 within the Jurisdiction of this Court By his Certain Bill obligatory which he the  
 said Deft Sealed with his Seale and as his deed delivered here into Court brought  
 the date whereof is the same day & year afd bound himself to pay unto the afd  
 ptt the afd full and just Quantity of six hundred and five pounds of good sound  
 Merchantable Tobacco well Condition Clear of all manner of trash & ground Leaves  
 in Carque to Containe the same of the afd value of six hundred Sterling money on  
 the then dwelling plantation of the afd Deft in the afd County on demand  
 after the tenth day of October next ensuing the date of the said Bill yett the  
 afd Deft the afd six hundred and five pounds of Tobacco to the said ptt hath not  
 paid afd to pay the same he the same Deft afterwards and after the
