 Thomas Rowe his atty^r saith that whereas the app^r Deft the 15th day of
 February in the year of our Lord Christ One thousand seven hundred and seven:
 teen at S^t. Pauls parish in Kent County within the jurisdiction of this Court
 by his certain Bill obligatory which he the said Deft sealed with his Seale
 and his deed delivered herunto Com^r brought the date whereoff is the same
 day and year app^r Rowd himself his Secy^r D^r. Edm^r. in the app^r sume
 of thirteen hundred pounds of Tobacco of the app^r value of thirteen pounds
 Sterd money for the true payment of the full and just quantity of six
 hundred fiftie pounds of good Sound Merchantable Tobacco Char of abo-
 manner of haff & ground Leases in Carque to Captaine the same Convent
 in the app^r County to the said p^t his Secy^r Edm^r. or assignes in and upon
 the tenth day of October next ensuing the date of the said Bill without
 Rand or further delay and the app^r p^t in deed saith that the app^r Deft
 hath not paid to the app^r p^t the app^r sume of six hundred & fiftie pounds
 of Tobacco in or upon the app^r tenth day of October which is from the said
 p^t at or upon the app^r day he the said Deft ought to have paid according
 to the forme and effect of the said Bill by which either hath accrued to
 the said p^t to read & have of the said Deft the app^r sume of thirteen
 hundred pounds of Tobacco yett the app^r Deft altho^e often required the
 app^r sume of thirteen hundred pounds of Tobacco to the said p^t hath
 not paid but that he from to render or pay therunto hath deneged and
 still doth denie & unjustly detain to the damage of him the said p^t &
 twenty six pounds Sterling money and thereupon he brings suite &
 Rowe & Deft p^t vs Doe & Roe

And now at this Court to wit this 19th day of August Anno Domⁱ.
 1719 here present the app^r Deft in his proper person comes & defends the
 force and injury w^{ch} he. And sayeth that he cannot gainway the p^t his
 Avow^r app^r So as app^r against him brought nor can he say but that the
 said p^t ought to recover his debt by equaton of the premises app^r to
 the same of thirteen hundred pounds of Tobacco and the app^r Deft against
 him which the said p^t does not gainway. Therefore it is considered
 by the Justices here the 19th day of August Anno Domⁱ. 1719 app^r that
 the said Philip's Remors recover against the said Matthew Deek as
 well the sume of thirteen hundred pounds of Tobacco his debt app^r in
 forme app^r as also the sume of two hundred forty seven
 pounds of Tobacco by the Court here asjudged him for his C^{ts} and
 Charges
