and there upon the said p^{tt} by Thomas Bourne his
attly. complains that whereas the said Deft^r the tenth day of ^{9th} in the
year of our Lord Christ one thousand seven hundred and eighteen at
parish in Kent County within the Jurisdiction of this Court was indebted to the
said p^{tt} in the sum of Three pounds sixteen Shillings and six pence
Current money of Maryland and the sum of one thousand five hundred
and seventy three pounds of Merchantable Tobacco for the like sum of
money and Tobacco by the said p^{tt} at the Justice and request of the said
Deft^r then and there for the use and behoofe of the said Deft^r to several
persons paid and laid out and so thereof being indebted the said Deft^r in
consideration thereof afterwards viz. the day and year aforesaid in the parish
County & Jurisdiction aforesaid upon himself assumed and to the said p^{tt}
then and there faithfully promised that he the said Deft^r the said sum
of Three pounds sixteen Shillings and six pence and one thousand
five hundred and seventy three pounds of Merchantable Tobacco to
the said p^{tt} when thereunto required would well and truly pay and
Content And that whereas also the said Deft^r afterwards viz. the Tenth
day of ^{9th} in the year of our Lord Christ one thousand seven hundred &
eighteen at the Parish County and Jurisdiction aforesaid in consideration that
the said p^{tt} had then and there last mentioned at the like Justice
and Request of the said Deft^r paid to a certain John Roberts Three pounds
sixteen Shillings and six pence Current money of Maryland and two
hundred sixty and five pounds of Merchantable Tobacco and to a certain
Richard Burrough one thousand three hundred and eight pounds of
Merchantable Tobacco in all amounting to one thousand five hundred
and seventy three pounds of Merchantable Tobacco and Three pounds
sixteen Shillings and six pence Current money of Maryland upon the
account and to the proper use and Benefit of the said Deft^r upon himself
assumed and to the said p^{tt} then and there last mentioned faithfully
promised that he the said Deft^r the said three pounds sixteen Shillings and six
pence Current money of Maryland and the said one thousand five
hundred and seventy three pounds of Merchantable Tobacco last mentioned
to the said p^{tt} when thereunto required would well and truly pay and
