 day of 9<sup>mo</sup> and often after in the Year 1718 in the afo County and Jurisdiction

 Content for the same but that to pay or Content the Said Debt  
 Suthors hath denied and yet denies to the damage of the Said p<sup>ty</sup>  
 thirty pounds Current money of Maryland and thereupon he brings  
 Suite &c

And the Said Garrett Cofsey by John Johnson his Atty comes  
 and defends the force and injury when &c And prays leave to impare  
 hereunto untill next Court and he hath it And the Same day is given  
 the p<sup>ty</sup> also

At the which Said next Court to wit the 16 day of June Anno Dom  
 1719 comes againe as well the Said p<sup>ty</sup> by his Atty as the Said Debt  
 by his Said Atty And rule is given to the Said Debt to put in a plea  
 to the afo Action otherwise Judgment to be rendered to the afo p<sup>ty</sup> want  
 thereof And thereupon the Same action is Continued untill the  
 next Court

At the which Said next Court to wit the 19 day of August Anno Dom  
 1719 comes againe the Said p<sup>ty</sup> by his Atty and no plea being  
 put in to the afo Action But the Said Garrett Cofsey altho' solemnly  
 called comes not but makes default whereby the Said p<sup>ty</sup> remains  
 against the Said Debt without further defence Therefore it is  
 Considered by the Justices here the 19 day of August Anno Dom 1719  
 that the Said Bennett Love Recover against the Said Garrett Cofsey  
 as well the Sum of Three pounds sixteen Shillings and Six pence  
 Current money of Maryland and One thousand five hundred and  
 Seventy three <sup>pounds of Tobacco</sup> his Damages by Ovation of the premises afo as also  
 the Sum of four hundred and fifty one pounds of Tobacco by the  
 Court here adjudged him for his Cost and Charges by him about his  
 Suite in this behalfe Expended and the Debt in money &c
