Three hundred eighty and eight pounds of Merchantable Tobacco unto the said p^tt when thereunto required would well and truly pay and Content And that whereas also the afo^d D^rft afterwards by the afo^d Second day of October in the year of our Lord Christ One thousand seven hundred and Seventeen at the Parish County & Jurisdiction afo^d had accounted with the afo^d p^tt afo^d concerning divers sums of tobacco by the afo^d D^rft to the afo^d p^tt before that time by the year of our Lord Christ one thousand seven hundred and Sixteen owing and unpaid and upon that Accounting he the said D^rft then and there last mentioned was found in arrearage towards the afo^d p^tt in the sum of Three hundred eighty and eight pounds of Merchantable Tobacco and also thereof being found in arrearage the afo^d D^rft in Consideration thereof afterwards by the afo^d Second day of October in the year of our Lord Christ one thousand Seven hundred and Seventeen at the Parish County & Jurisdiction afo^d upon himself assumed and to the said p^tt then and there last mentioned faithfully promised that he the said D^rft the afo^d sum of three hundred eighty and eight pounds of Merchantable Tobacco to the said p^tt when thereunto required would well and truly pay and Content And whereas also the afo^d D^rft afterwards by the afo^d fifth day of December in the year afo^d at the Parish County and jurisdiction afo^d in Consideration that the afo^d p^tt at the said Special Justame and request of the afo^d D^rft had then and there last mentioned sold and delivered unto the afo^d D^rft and to the proper use and behoof of the afo^d D^rft diverse other goods wares & Merchandizes at the several rates and prises in an tuo. hereunto annexed set forth in the whole amounting to the sum of two hundred and Sixty pounds of Merchantable Tobacco upon himself assumed and to the said p^tt then and there last mentioned faithfully promised that he the said D^rft the afo^d sum of two hundred and Sixty pounds of Merchantable Tobacco unto the said p^tt when thereunto required would well and truly pay and Content And that whereas also the afo^d D^rft afterwards by the afo^d fifth day of December in the year afo^d at the Parish County & Jurisdiction afo^d in Consideration that the afo^d p^tt at the said Special Justame & Request of the afo^d D^rft had then and there last mentioned sold and delivered to the said D^rft and to the proper use & behoof of the said D^rft diverse other goods wares and Merchandizes in an tuo. hereunto annexed particularly set forth upon himself assumed and to the same p^tt then and there last mentioned faithfully promised that he the said D^rft so much Merchantable Tobacco as the afo^d Goods wares and Merchandizes last mentioned sold and delivered as afo^d at the time of the sale & delivery of the same were reasonably worth to the same p^tp when thereto afterwards he should be required would well and truly pay and Content And the afo^d p^tt
