give special Baile as afo. But the said ptt in his proper person came  
into Court the same day last mentioned and releases the said Dett from  
the Commitment for special Baile as afo

Lowes of plea that he render him the full & just sum of  
Six thousand Seven hundred and forty pounds of Tobacco of the value of  
Sixty pounds Sterling money which from him he unjustly Detaines and  
whereupon the ass ptt. by Thomas Bowne his atty saith that  
whereas the ass Dett the second day of September in the year of our  
Lord Christ one thousand Seven hundred and Eighteen at S. Pauls Parish  
in Kent County within the Jurisdiction of this Court by his Certain writing  
Obligatory which he the said Dett Sealed with his Seale and as the  
deed delivered here into Court brought the date whereof is the same  
day & year afo granted himselfe holden & firmly bound unto the  
ass ptt. in the ass full & just sume of Six thousand Seven hundred and  
forty pounds of Tobacco of the ass value of Sixty pounds Sterling money  
to be paid unto the ass ptt. when thereunto Required yet the ass Dett  
altho' often required the ass sume of Six thousand Seven hundred &  
forty pounds of Tobacco to the said ptt. hath not paid But that to him  
to render or pay he the said Dett hitherto hath denied and still doth deny  
and unjustly detaine to the damage of the ass ptt. twenty pounds Sterling  
money afo and thereupon he brings Suite &c.
