And now at this Court to wit the 15 day of March Anno Dom 1719 comes
the app Debt and defends the force and injury when &c And Says that he
Cannot gainsay the p'tt his action app so as app against him brought nor
can he say but that the Said p'tt ought to recover his Debt by Oration
of the premises app with lot of Sute which the Said p'tt does not gainsay
Therefore it is Considered by the Justices here the 15 day of March
Anno Dom 1719 app that the Said Cement Barkston Recover against the
Said Phillip Holcadger as well the Sum of Nineteen hundred fifty
Six pounds of Tobacco his Debt app for same app Confessed as also the Sum
of Two hundred Thirty Nine pounds of Tobacco by the Court here adjudged to
him for his Costs and charges about his Suite in this Behalf laid out and
expended and the Debt in money &c.
