the app Summe of one thousand six hundred fifty six pounds of Tobacco of
the quality & value app firmly by the Bill obligatory app and the app ptt
in fact faith that the app Deft hath not paid to the app ptt the app Summe
of eight hundred twenty eight pounds of Tobacco of the quality and value
app in forme app as to him he ought to have paid according to the tenor
and effect of the Said Bill obligatory by which covenation hath accrued to
the Said ptt to have & receive of the Said Deft. the app Summe of one
thousand six hundred fifty six pounds of Tobacco of the quality & value
app Nevertheless the app Deft the app Summe of one thousand six hundred
fifty six pounds of Tobacco of the quality & value app altho often thereunto
required by the Said ptt at the parish County & Jurisdiction app he the Said
Deft hath not rendered or paid but that to the Said ptt to render or pay
hither to hath denyed & still doth deny & unjustly detains to the damage
of the Said ptt sixteen pounds Sterling & thereupon he brings Suit W.
Cooke & Quer ptes &c. In Doe & C. Riddell &c

Whereupon John Denning of Kent County planter present here in
Court undertakes for the Said Andrew Riddell that if in case the Said
Henry Lowe shall recover Judgment ~~in~~ the plea app against the
Said Andrew Riddell or that he the Said Andrew Riddell shall be
therein convicted that then he the Said Andrew Riddell shall pay the
Exemplification of the Court thereupon or render his body to the Custody of
the Sheriff of Said County in Satisfaction thereof or that the Said John
Denning will do it for him

And now at the Said Court to wit the 15 day of March Anno Domini 1719 comes
the Said Deft and defends the force and injury when W. And says that he
cannot gainsay the ptt his action app so as app ag. him brought nor can
he say but that the ptt ought to recover his debt by execution of the
premises app with costs of suite which the Said ptt does not gainsay
Therefore it is considered by the Justices here the 15 day of March Anno
Domini 1719 app That the Said Henry Lowe recover against the Said
Andrew Riddell as well the Summe of one thousand six hundred fifty
six pounds of Tobacco his Debt app in forme app Confessed as also the
Summe of three hundred and three pounds of Tobacco app by the Court
