

and sixteen at St Pauls parish in Kent County within the Jurisdiction of this Court was indebted unto the ap^{ts} in the sume of seven hundred and three pounds of Merchantable Tobacco for the like sume of Tob^o of the ap^{ts} by the ap^{ts} Deft and to the use and behoofe of said Deft before that time had and recd. and so thereof being indebted the ap^{ts} Deft in Consideration thereof afterwards viz the ap^{ts} third day of January in the Year ap^{ts} at the parish County and Jurisdiction ap^{ts} upon himself assumed and to the said pt then and there last mentioned faithfully promised that he the said Deft the ap^{ts} sume of seven hundred and three pounds of Merchantable Tobacco unto the said pt when thereunto required would well and truly pay and Content And that whereas also the ap^{ts} Deft afterwards viz the ap^{ts} third day of January in the Year ap^{ts} at the parish County and Jurisdiction ap^{ts} had accounted with the ap^{ts} Deft of an accounting divers Sums of Tobacco by the ap^{ts} Deft to the ap^{ts} pt before that time owing and unpaid and upon that accounting he the said Deft then and there last mentioned was found in Arrearage towards the ap^{ts} pt in the sume of seven hundred and three pounds of Merchantable Tobacco and so thereof being found in Arrearage the ap^{ts} Deft in Consideration thereof afterwards viz the ap^{ts} third day of January in the Year ap^{ts} at the parish County and Jurisdiction ap^{ts} upon himself assumed and to the said pt then and there last mentioned faithfully promised that he the said Deft the ap^{ts} sume of seven hundred and three pounds of Merchantable Tobacco to the said pt when thereunto required would well and truly pay and Content Here the ap^{ts} Deft in severall promises and assumption ap^{ts} in form ap^{ts} made telle regarding but plotting and fraudulently Intending him the said pt in that behalfe craftily and subtilly to deceive and defraud the ap^{ts} severall Sums of Tobacco in the whole amounting unto the sume of fourteen hundred and six pounds of Tob^o to the said pt altho afterwards viz the fourth day of January in the Year of our Lord Christ one thousand seven hundred and sixteen and after after at the parish County and Jurisdiction ap^{ts} he the said Deft by the said pt was thereunto required hath not paid nor made Content for the same but that he the said Deft hath the said Deft hath done and shd doo duty to the damage of him the said pt two thousand pounds of Merchantable Tob^o & therefore he being Sute &c.
