Whereupon the Said Edward Mitchell by Thomas Bourne his attorney prays that forasmuch as he hath Complied with the Law in order for an attachment he may have judgement against the S^r Josiah Richardson for his Damages by occasion of the premises by way of an attachment according to act of Assembly Whereupon for that it seems to the Court here the 28th day of July Anno Dom 1720 that the S^r Edward Mitchell hath Complied with the Law. Therefore it is Considered by the Justices this 28th day of July Anno Dom 1720 a^t that the S^r Edward Mitchell Recover against the S^r Josiah Richardson as well the Sum of thirteen pounds Eighteen Shill and Eight pence Current money and Nine hundred and Eighty two pounds of Tobacco his Damages a^t as all so three hundred and fourteen pounds of Tobacco Costs and Charges laid out and Expended by the S^r Edward Mitchell in this Suit by way of an attachment against the Goods Chattels Rights and Credits of the S^r Josiah Richardson according to act of assembly in such Cases made and provided
