Attorney Complainette that whereas the ap^d Deft^s viz^t the Seventh day of December in the year of our Lord Christ one Thousand Seven hundred and Seventeen at St. Pauls parish in Kent County within the Jurisdiction of this Court in Consideration that the ap^d p^t at the Special instance and request of the ap^d Deft^s had then and there Sold and delivered unto the ap^d Deft^s and to the proper use and behoofe of the ap^d Deft^s divers goods and Merchandizes for the Summe of five hundred and fifty two pounds of Merchantable Tobacco in manner as in the Decree hereto Annexed at the severall rates and prices set forth upon himselfe assumed and to the said p^t then and there faithfully promised that he the said Deft^s the ap^d Summe of five hundred and fifty two pounds Merchantable Tob^o to the said p^t when thereunto required would well and truly pay and Content and that whereas also the ap^d Deft^s afterwards viz^t the ap^d Seventeenth day of December in the year ap^d at the parish County and Jurisdiction ap^d in Consideration that the ap^d at the like Special instance and request of the ap^d Deft^s had then and there last mentioned Sold and delivered unto the ap^d Deft^s and to the proper use and behoofe of the ap^d Deft^s divers goods and Merchandizes in said Decree hereto Annexed set forth upon himselfe assumed and to the said p^t then and there last mentioned faithfully promised that he the said Deft^s so much Merchantable Tobacco as the ap^d last mentioned Goods and Merchandizes Sold & delivered as last said at the time of the Sale & Delivery thereof at reasonable rates and prices were worth and amounted to unto the said p^t when thereunto required would well and truly pay and Content and the ap^d p^t indeed saith that the ap^d last mentioned Goods and Merchandizes Sold and delivered as last said at the time of the Sale and delivery thereof at reasonable Rates and prices were worth and amounted unto the Summe of five hundred and fifty two pounds of Merchantable Tob^o in manner as in the said Decree set forth of which the said Deft^s then and there last mentioned had Notice Nevertheless the ap^d Deft^s his promises and Assumptions ap^d in forme ap^d made Litle regarding but plotting and fraudulently pretending unto the said p^t of the ap^d severall Summes of Tobacco which in the whole amount unto the Summe of Eleven hundred and four pounds of Tobacco craftily and Subtily to deceive and defraud the ap^d Summe of Eleven hundred and four pounds of Tobacco to the said p^t altho he the said Deft^s afterwards viz^t the Second day of Feby in the year ap^d often after at the parish County and Jurisdiction ap^d was thereunto required hath not paid nor made Content for the same but that to him to pay or Content the said Deft^s hatherto hath done and still doth duty to the damage of him the said p^t Eleven hundred pounds of Merchantable Tobacco and thereupon he brings
