

Value of five pounds Sterling money which from him he unjustly detaineth
 and that he have them and there the said writ is. All which said next Court
 viz the seven tenth day of June Anno Domini One thousand Seven
 hundred and Eighteen the day of return of said writ came Simon Wilmer
 Gent high Sheriff of Kent County and made return thereof in these words
 thereon I did as follows viz. Capi Corpus p J. Wilmer the
 and a Deed being filed when said writ issued forth and a Copy thereof
 served thereunto according to Act of Assembly in such case made as
 follows viz. Kent County p. Thomas Morell of Kent County planter and Did Thomas
 Morell of Queen Besses County planter was summoned to shew into Thomas
 Bowne of a plea that he owes him the sum of five hundred pounds of
 good sound Merchantable Tobacco in Cash of the value of five pounds
 Sterling money which from him he unjustly detaineth

and whereupon the app ptt in proper person saith that whereas the app
 Deft the Family Sixth day of November in the year of our Lord Christ one
 thousand Seven hundred and thirteen at Spauls parish in Kent County
 within the Jurisdiction of this Court by his certain writing obligatory which he
 the said Deft sealed with his Seal and as his deed delivered hereinto.
 Court brought the date whereof is the same day & year as granted himselfe
 taken and firmly bound unto the app ptt in the app sum of five hundred
 pounds of good sound Merchantable Tobacco in Cash of the app value of five
 pounds Sterling money to be paid unto the said ptt when thereunto required
 yet the app Deft altho' often required the app sum of five hundred pounds
 of Tobacco unto the said ptt hath not paid but that he him to render or pay the
 said Deft hitherto hath denied and still doth deny and unjustly detaineth the
 Damage of him the said ptt seven pounds Sterling money unto him upon
 he being sate &c. *Wm. of Spauls John Johnson p. J. Doe*

And the app Deft being called came and the app ptt pray that the said Deft
 may give special Baile to the app Action which is granted and that he be
 kept in safe Custody by the Sheriff of said County until he shall give special
 Baile as app

after which William Simson of said County here in Court cometh and acknowledg
 edged himselfe as special Baile in the app Action and doth undertake for
 the app Deft the payment of the Debt app and all thereon accruing if the
 said Deft should be cast in the same and the Condemnation shall not
 satisfy nor himselfe to the Custody of the Sheriff of said County deliver or
 that the app William Simson the Body of the app Deft shall not render &c.

And the app Deft in his proper person appeared to the app Action and saith
 that he cannot gainsay the Action app of him the said ptt nor but that the
 writing obligatory above mentioned is his Act and deed and that he oowth unto
 the app ptt the app sum of five hundred pounds of Tobacco and is willing
 that Judgment should be entered for the same & all thereon accruing: *Wm. of Spauls*
