Whereupon the said Thomas Dashiell by his attorney and Gray that for as much as he has Complied with the Law in Order to an attachment he may have Judgment against the said Anthony Moore for his Debt and by way of attachment according to act of assembly *Et c.* Whereupon for that it seems to the Court that the said Thomas Dashiell has Complied with the Law as alleged

Therefore it is Considered by the Justice here the Sunday and Year last mentioned that the said Thomas Dashiell recover against the said Anthony Moore as well the Sum of two thousand One hundred and Ninety two pounds of tobacco his Debt and as all Costs and Charges by the Court laid out and Expended about his Suite by way of attachment against goods, Chattels, Rights, or Credits of the said Anthony Moore according to act of assembly in such Case made and Provided for

Robert Martin - Command was given to the Sheriff of Somerset County that he should take William Gilchrist and Thomas Brown late of all hollows Parish in the County of Somerset Merchants if they should be found in his Parish and that he should safe Keep so that he might have their Bodies

Before the Justice of this Lordships County Court of Somerset to be hold at Diving Creek of the third Tuesday of March then next to answer unto Robert Martin of a plea of trespass upon the Case and that there of he should not fail *Et c.* And whereupon the said Robert by Francis Allen his attorney complains that whereas the said Wm and Thomas the third day of February in the Year of Our Lord God One thousand Seven hundred and twenty One at the said Parish and County and within the Jurisdiction of this Court were Indebted unto the said Robert in the Sum of fifteen pounds twelve Shillings and three pence and Eighteen hundred Ninety Eight pence of tobacco as by an account there of here in Court ready to be produced may appear and so there of being Indebted the said Wm and Thomas afterwards to wit the said third day of February in the year aforesaid at the County aforesaid and within the Jurisdiction aforesaid in Consideration thereof upon their oaths did assume and unto the said Robert then and there faithfully did promise that they the said Wm and Thomas the said fifteen pounds twelve Shillings and three pence and Eighteen hundred and Ninety Eight pence of tobacco unto the said Robert when there of afterwards they should be required would and faithfully would pay and Content and altho the said William and Thomas to be Coupled of the said fifteen pounds twelve Shillings and three pence and Eighteen hundred and fifty pence of tobacco Coupled of the said fifteen pounds twelve Shillings and three pence and Eighteen hundred and Ninety Eight pence of tobacco to the said Robert they have paid and satisfied yet as to four pounds three Shillings and four pence and three hundred forty Eight pence of tobacco residue of the said fifteen pounds twelve Shillings and three pence and Eighteen hundred Ninety Eight pence of tobacco the said Wm and Thomas their promise and assumption aforesaid in form aforesaid made little regarding but minding and fraudulently Intending the said Robert in this Court Craftily and Subtly to do owe and defraud the said four pounds three Shillings and four pence and three hundred forty Eight pence of tobacco or any part thereof unto the said Robert they have not paid or in any Court Contented altho to do so
