And whereupon the said Robert by Francis Allen his attorney complains that whereas the said Peter the thirtieth day of November and Dunt One thousand seven hundred and twenty two at the parish and County aforesaid within the Jurisdiction of this Court was indebted unto the said Robert in One thousand two hundred fifty and two pounds of tobacco for Levies and publick dues and forbearance thereupon to the said Robert then and there due owing and unpaid as by an account thereunto annexed may in Court appear a being so thereof indebted the said Peter in consideration thereof upon himselfe did assume and to the said Robert then and there did faithfully promise that the said Peter the aforesaid One thousand two hundred and fifty two pounds of tobacco to the said Robert when he should afterwards thereunto requested he would well and faithfully pay content altho. the said Peter One hundred and sixteen pounds of tobacco parcel of the aforesaid One thousand two hundred and fifty two pounds of tobacco to the said Robert he hath paid and satisfied yet as to Seven hundred thirty six pounds of tobacco residue of the aforesaid One thousand two hundred and fifty two pounds of tobacco the said Peter his promise and assumption aforesaid made little regarding but plotting & fraudulently Intending the said Robert in that sort craftily and subtilly to deceive and defraud the aforesaid Seven hundred and thirty six pounds of tobacco to the said Robert he hath not paid or to him for the same many sort Contented altho the same to doe the same Peter by the said Robert on the first day of December in the year aforesaid and often afterwards at the County and parish aforesaid within the Jurisdiction aforesaid he was thereunto requested but the same to him to pay or in any wise to Content hath refused and shall do the refuse and deny whereupon the said Robert saith he is worse and hath damage to the value of two thousand two hundred and seventy two pounds of tobacco & thereupon he brings Suit &c
