At which said third Tuesday of March to wit the Seventeenth day of the same month and at one thousand seven hundred & twenty three being the day of the return of the said writ Cometh the Sher. of Somerset County and maketh return thereof to the Court here Endorsed in these words following viz

Whereupon the said Katherine Pyne being sett to the Bar (Presentment read) is there upon Instantly demanded how she would acquit herself of the premises aforesaid imposed on her, Says that of the premises aforesaid she is guilty thereof & Submits to the Mercy of the Court & makes oath that a certain John Saylor is the Beggetter of the said fine & is willing to pay her fine for the fact aforesaid. — Wherefore it is Considered by the Justice here that the said Katherine Pyne be fined to his Lordship the Lord proprietary the Sum of thirty Shillings for the fact aforesaid there upon the said Katherine Pyne is ordered to give Security for the payment of the fine aforesaid and the several Officers their fees by Occasion of the premises aforesaid. there upon a certain Jeffery Long of Somerset County Gent. master of the said Katherine Pyne present here in Court pays thirty Shillings for the fine aforesaid & Enters into Recognizance in five pounds Court money to be levied on his goods & chattels Land & Tenements & In Case he doth not pay unto the several Officers their fees that accrued upon the presentment aforesaid by Occasion of the premises aforesaid. — Whereupon It is Ordered by the Court that the said Katherine Pyne serve her said Master three full months, to Commence from the Expiration of her said term it being adjudged by this Court to be full satisfaction for one halfe of the damage trouble & Loss of time that the said Jeffery Long was at, at the time of the said Katherine Pyne's being in with Court & —
