form fore and Effect of the same and to punish and punish all or any Person or persons Offending
against any the said Ordinances or Statutes according to the directions thereof and to call before you
or any of you all those who in our County aforesaid shall threaten to do any bodily harm to any of our
good people or to burn their houses or otherwise break our Peace and misbehave themselves
to find sufficient Security of the Peace of the County and good Behaviour toward our good Peo-
ple and if they shall refuse to find such Security then you Cause them to be committed into safe
Custody until they shall find the same also we have assigned you and Every three or more of
you, of whom we will you the said Justice to call, Joseph Gray Samuel Hopkins, and
William Whittington or One of you always to be our Justices to Enquire by the Oaths of good
and Lawfull men of our County aforesaid by whom the truth of the Commissions may be better known of
all and all manner of Sorcery Witchcrafts Enchantments Sorceries arts Magick Forgeries Engra-
vings Rogatings frauds tallies and Extortions whatsoever and of all and all other Mischances
and Offences whatsoever of which Justices of our Peace Lawfully may or ought to Enquire by
whomsoever or howsoever in our County aforesaid done or committed or which hereafter may happen to be
done or attempted and also all those who in our County aforesaid in riotous Manner have gone or rode
or shall hereafter presume to go or ride with armed forces against our Peace to the disturbance
of our Peace and of all such who in our County aforesaid have slain or shall hereafter be slain
to lay in wait to maim or kill any of our said People and also of all ordinary Keepers and such
Other persons who have Offended or attempted to Offend or hereafter shall presume or Offend or
attempt to Offend in the abuse of weights and measures or in Selling of any Liquors according to
the form of the Act of Assembly for the Common good and Profit now in this Province made and used
and also of the Sheriffs Bayliffs Constables and Other Officers who have and shall hereafter Misbehave
themselves in the Execution of their Offices or have been so negligent in the Execution
thereof or shall hereafter happen to be within our County aforesaid and of all and Every the articles
matters and things whatsoever howsoever or by whomsoever in our County aforesaid done or committed or
that shall hereafter happen to be done or attempted concerning the Commissions or any of them or to
Inquire all Judgments so before you or any of you taken or to be taken or before our Justices
of the Peace within our said County had and taken and not yet determined and Executed the same
all and any person or persons so Judged or which shall hereafter happen to be Judged
in our County aforesaid to make and continue until they shall be taken Surety or themselves to be
bound and to hear and determine all and Every the following witchcrafts Enchantments Sorceries arts
Magick Forgeries frauds tallies Rogatings Engravings Rogatings Rights Judgments and all other the matters
aforesaid according to the Law of Great Britain and this our Province had and used or to be had and
Used and said Delinquents and Every of them to punish and punish by such means and man-
ners and otherwise according to said Law and Customs of said Kingdom of Great Britain
