Thereupon Command is given to the Sheriff of Somerset County that immediately he cause to come here to close &c. by whom &c. who neither &c. to language &c. because it were &c. of which said principle the said the said Sheriff to wit Joseph McCarter makes return that he hath there ready twelve &c. as by his principle he was commanded and the Jurors therein Impanelled being called came to wit, Edward Round William Hardy Joseph Houston, Daniel Ordry, Giddon Tilsman, Richard Phillips John Nichol - son, John Scambrough, William Richardson John Gilett, John Little George Barston who being duly elected tried and sworn today the truth in the premises upon their Oath do say that the said Wm Cambell is guilty of the premises as by the Inditment above is supposed upon him &c.

Wherefore it is considered by the Justice here that the said William Cambell be whipt ^{on the back} at the public whipping post with thirty Nine lashes well laid on ^{at the public} until the blood appear, and to stand in the pillory six hours and that he taken &c. and thereupon as to the Corporal punishment aforesaid Command is given to the Sheriff of Somerset County that he do thereof Immediately Execution according to the Judgment aforesaid rendered by whipping the said William Cambell at the public whipping post with thirty Nine lashes on the bare back well laid on until the blood appear and by sitting him in the pillory six hours, afterward in the same Court the Sheriff returns that he hath done the Execution of the Judgment aforesaid as aforesaid he was commanded. Whereupon it is ordered by the Court that the Sheriff of Somerset County take the said William Cambell into his Custody, and him return to his Mistress the wife of Capt John Dolan if she will receive him, but if she will not receive him, but knoweth or disclaimeth any Right to him, & if for other person appears to say Claim to the said Cambell, that then the said Sheriff is hereby ordered to give due Notice, and at some place by him to be appointed to dispose and make Sale of the said Wm Cambell to the highest Bidder not exceeding seven years, and when the same shall so done to make report thereof to this Court, to be bound to the County the fees due upon the premises aforesaid &c.
