whipping post with ten lashes on the Bare Back well laid on untill the blood appear and that she
be taken &c. and thereupon as to the forgoone punishment of her Command is given to the Sherif of Somerset
County that he do thereof Immediate Execution according to the Indictment and Pardon by whipping the said
Sarah Poton at the publick whipping post with ten lashes on the Bare back well laid on untill the blood
appear and afterwards in the same Court the Sherif. Returns that he hath done the Execution of the Indictment
as to the forgoone punishment of her Commanded whereupon the said Sarah Poton is discharged
from her Recognizance of the quiering Surety for payment of the several Officers their fees &c. Whereupon
a certain Isaac Potten present here in Court undertakes for the said Sarah Potten and acknowledged himself
to be & stand Indebted unto his Lordship his heirs & Successors with the sum of ten pounds Sterl
to be paid &c. In Case he does not pay the several Officers their fees due by reason of the premises and so.

Thereupon Command is given to the Sherif of Somerset County that he should take the said

of the Sherif and being sett to the Bar presentment made, pleads guilty & submits to the Mercy of the Court &c.
makes Oath that a certain Richard Driskill is the father of the Child she stands presented for, but hath not
wherewithall to pay her fine for the fact and so. - Wherefore it is considered by the Justices that the said
Hannah Ford be whipt at the publick whipping post and there whipt with ten lashes on the Bare back well
laid on untill the blood appear and that she be taken &c. and thereupon as to the forgoone punishment
of her Command is given to the Sherif of Somerset County that he do thereof Immediate Execution according to
the Indictment and Pardon by whipping the said Hannah Ford at the publick whipping post with ten lashes
on her Bare back well laid on untill the blood appear and afterwards in the same Court the Sherif
Returns that he hath done the Execution of the Indictment as to the forgoone punishment of her Command.

Whereupon a certain Moses Driskill present here in Court acknowledged himself to be & stand Indebted
unto the Right Honourable the Lord Proprietary with the sum of ten pounds Sterl to be paid &c. In
Case he does not pay the several Officers their fees due by reason of the premises upon the presentment and so.
