 to a hick nut tree ^{that was} for Bowler for Kink said it was the dividing tree of two tracts
 of Land and they would wrong each other of the timber which tree appears about one
 hundred yards from the shore of water and 30 yards from the Cornut tree and declared
 that a line was broken as appears this far of the blind Boundary and further submitted
 as witness my hand this 14th day of June in 1724 - Anthony Bess
