At which said third Tuesday of March to wit the Nineteenth day of the same Month the said Court being then and seven hundred and twenty two came being the day of the return of the said Writ under the Great Seal of Somerset County to whom the foregoing was directed And matters taken there of returned by

Whereupon the Court adjourned until the last Tuesday in April being the thirtieth day of the same month. And doth then show and seven hundred and twenty three. At which day the Court doth again and thereupon came the said Esther Bluelton and being by the Court set to the Bar in thereupon Instantly demanded how she would acquit herself of the Grievances above Imposed upon her. Says that of the Grievances aforesaid she is guilty thereof and submits to the mercy of the Court - and makes oath that certain Thomas Roucher is the brother of the Child she stands bound for, and is willing to pay her fine for the fact aforesaid. Wherefore the said Esther Bluelton by Consideration of the Justice here is fined to his Lordship the Sum of thirty Shillings Court money for the fact aforesaid. Whereupon she is discharged paying her fine and fees, and is ordered to give Security for the paying the same. Whereupon her brother James Bluelton Esquire took in Court undertakes for the said Esther Bluelton to pay the fine aforesaid and the Court Officers their fees due by action of the Grievances aforesaid. Whereupon it is ordered by the Court that the said Esther Bluelton give Recognizance in five pounds Court money for her appearance at the County Court to be held at dividing Creek the third Tuesday of June next to give Evidence against the said Thomas Roucher on behalf of the said Proprietary and not to depart the said Court without License thereof.

Whereupon the said Esther Bluelton acknowledged her self to be bound and stand Justly Indebted unto his Lordship the said Proprietary in the Sum of five pounds Court money to be paid on her being goods and Chattels Lands and Tenements to the use of his said Lordship the said Proprietary - his heirs and Successors. In Case the said Esther Bluelton do not make her personal appearance at the County Court of Somerset to be held at dividing Creek the third Tuesday of June next to give Evidence on behalf of his said Lordship against certain Thomas Roucher and not to depart the said Court without License thereof, then the above Recognizance to be void & otherwise to stand and remain in full force and virtue &c

And whereupon the said Johannes by Francis Allen his attorney complains that whereas the said Gabriel the sixteenth day of March in the year of our Lord God one thousand seven hundred and seven ten at Somerset County and within the Jurisdiction of this Court was Indebted unto the said Johannes in the Sum of five thousand eight hundred seventy and nine pounds of ten for sundry Credits by him given and for meat and drink and one servant woman by the said Johannes - was unto the said Gabriel at the special Instance and request of the said Gabriel before that time thereof and delivered as by an ant. Hereof the said Court ready to be produced may appear and so there of being Indebted the said Gabriel afterwards to wit the said sixteenth day of March in the year 1723
